• Overall income and expense are in good shape. Over budget for Insurance policy increase. Tree maintenance has a surplus of \$4200 for the year.

### Committees:

- We Care Nothing to report. Neighborhood looks good with no weeds.
- <u>ACC</u> Approx. 1/2 dozen requests: (1) driveway extension denied, (4) painting requests approved, (1) roof replacement approved.
- <u>Beautification</u> Rich Sisco will maintain position as head of committee. Rich has started putting flags at Frye entrance for new plantings. The planting list which will be emailed to Elan from Bart totals \$867. *Bart* motioned to increase the planting list allotment not to exceed \$1000. This will allow for (33) plantings per Rich's letter. PRR will determine the best time for planting. *Kathleen* seconded the motion. There were no comments. **Motion passed unanimously.**
- <u>Social</u> There were (14) attendees at the social. Rich Sisco was presented a Certificate of Recognition for his 9 year efforts and time on the Beautification committee and Board.
- <u>Block Watch</u> No issues. Gates to backyards are being kept closed. Garage doors are not being left open.

### New Business:

- Review 2025 Draft Budget and approve 2025 monthly dues:
  - Landscaping contract was negotiated with a 3% increase vs. the requested 5% increase.
